2019 NomCom Report

Introduction

The Nomination Committee 2019 was set up on 1 February and is constituted of the following members:

The Nomination Committee is responsible to ensure that appropriate candidates are nominated to contest for open seats and that all elections are successfully conducted according to current procedures. It was authorized by the Board to start its work on 11 February.

It should be noted that the Nomcom had requested Board extension approval in order to seek more candidates for Board and Govcom and the Board had granted extension which technically moves the Board approved timeline

AFRINIC Board of Directors elections

The Nomination Committee opened the call for nominations on 18 March for Seat 1, Seat 2, Seat 5, Seat 6 and Seat 7 for the Afrinic Board elections. It received 11 nominations. The Nomination Committee decided to reopen the call for nominations as it did not receive a satisfactory number of applications. It held a Webinar on 25 April to explain the process and to provide feedback to the Community.

The Nomination Committee defined a methodology for due diligence as that is required by Section 12.14(i) and Section 13.10 of the Afrinic Bylaws. As there were some hurdles, the Nomination Committee ended up having to collect and confirm the identities of nominees. The Nomination Committee received an email about the withdrawal of one of the nominees. The Nomination Committee approved eight nominees for the Afrinic Board election process.
